Dear colleagues, young scientists, students!



The Temirbek Zhurgenov Kazakh National Academy of Arts is organizing the **VI International Scientific and Theoretical Conference for Young Scientists and Students "Three Pillars of Kazakh Literature – Three Fates,"** dedicated to the **130th anniversary of S. Seifullin, I. Zhansugurov, and B. Maylin.**

The purpose of the conference is to exchange contemporary scientific information and practical experience on pressing issues in the humanities and arts, as well as to foster a scientific worldview, national self-awareness, and an active civic position among Kazakh youth through the lives and works of outstanding writers and public figures Saken Seifullin, Ilyas Zhansugurov, and Beimbet Maylin, who enriched national literature with diverse themes, content, and artistic discoveries, introduced new methods and styles, and provided a significant impetus for the development of genres in Kazakh literature.

The VI International Scientific and Theoretical Conference will take place on April 10, 2025, at 10:00 AM at the Temirbek Zhurgenov Kazakh National Academy of Arts, located at 127 Panfilov Street, Almaty.

Main Directions of the Conference:

1. The role of the legacy of S. Seifullin, I. Zhansugurov, and B. Maylin in Kazakh culture.
2. Integration of interdisciplinary research: a pathway to a new understanding of modern science.
3. Culture and art: searches and discoveries.

Students, master's students, doctoral candidates, and young university lecturers are invited to participate in the conference.

The deadline for submitting conference materials is March 24, 2025.

Participation can be in-person or online via ZOOM (for participants from other cities).

Languages of the conference: Kazakh, Russian, English.

All expenses for participants from other cities will be covered by the sending party.

When preparing the report, authors are asked to follow these rules:

1. Please adhere to the specified text requirements. If the formatting requirements for the electronic version of the report are not met, the organizing committee reserves the right to reject the report for publication.
2. Volume - up to 5 pages in Microsoft Word. Font: type - Times New Roman, size - 12, single line spacing; paragraph - 1.25 cm, paragraph indentation is set automatically. Margins: top and bottom - 2.0 cm, left and right - 2.0 cm. The title of the report - in capital letters, bold, centered. Below, with one line space, on the right: author's full name - italic, bold (for each author - last name, space, then initials). On the next line, right-aligned, italic - indicate the name of the university, city, country; on the next line, right-aligned, italic - provide the scientific supervisor's details (full name, position, academic degree).
3. One line space, justified - abstract (an abstract in English for reports in Kazakh and Russian, and an abstract in Kazakh or Russian for reports in English).
4. In-text citations should be indicated in square brackets with the order number of the source in the list and, after a comma, the page number(s), e.g., [4, p.89]. A list of references for cited sources is mandatory. The list is placed at the end of the text and separated by a blank line. Sources in the list are indicated in the order they are cited in the text.

The best reports will be awarded diplomas.

The organizing committee reserves the right to select materials for publication. Materials submitted after the deadline or that do not meet the requirements will not be considered and will not be returned. Authors are responsible for the scientific content of their reports, their stylistics, grammar, and punctuation.

Scientific articles will be published in a collection of conference materials in **PDF format with an assigned ISBN**. There is no fee for publishing articles. A fee of 500 KZT is charged for a conference participation certificate if the presentation is made online or offline (optional).
