Report about a business trip to St. Petersburg (Russia) from 02 to 08 June

2024 From 02 to 08 June 2024, Head of the Laboratory of Legal Research at the EPI KarU Kazpotrebsoyuz Research Institute, Doctor of Law, Professor. Bakishev K.A. and a leading researcher at the Research Institute of EPI KarU Kazpotrebsoyuz Fetkulov A.H. were on a business trip to St. Petersburg (Russia) in order to fulfill the calendar plan of a scientific project on the topic: "Criminal law and criminological measures to ensure safety during mining or construction work" (IRN AR 19675171). During the business trip, the following tasks were solved: - collection of empirical material on the research topic and official statistics (survey and questionnaire); - analysis of investigative and judicial practice, foreign experience in the field of countering offenses in the field of occupational safety and health; - meeting with experts and scientists dealing with problems in the field of safety during mining or construction work. The duration of the business trip to St. Petersburg was 5 days.

Arrived on June 02, 2024 in St. Petersburg, Russian Federation, at St. Petersburg State University of Economics (Griboyedov Canal nab., 30-32, letter A). The Faculty of Law of the St. Petersburg State University of Economics is one of the oldest law faculties, which employs prominent scientists, legal scholars with scientific papers and practical experience in combating labor protection offenses. In particular, the faculty of the Department of Criminal Law and Criminal Procedure of the St. Petersburg State University of Economics (ul. 7-I Krasnoarmeyskaya, 6/8) take part in the preparation of educational and methodological literature, publish scientific works on criminal law, criminology, criminal procedure and criminology (author's monographs, educational materials, scientific articles), make presentations at scientific and practical conferences and other scientific events on the problems of violation of safety regulations, industrial sanitation or other labor protection rules, violations of the rules during the introduction of mining or construction work, ensuring safety during the introduction of work in special conditions (nuclear energy, space activities). The Faculty of Law of the University includes six departments: the Department of Theory and History of State and Law; the Department of Constitutional and Administrative Law; the Department of Civil and Corporate Law; the Department of Criminal Law and Criminal Procedure; the Department of Financial Law; the Department of Business and Energy Law.





We visited the Federal State Budgetary Educational Institution "St. Petersburg State University of Economics" (Griboyedov Canal nab., 30-32, letter A). We met with Deputy Head of the Department of International Cooperation Skurikhina Ekaterina Viktorovna. They discussed issues of scientific and educational cooperation between the two universities, outlined the purpose and objectives of the business trip, and strengthened further partnerships between universities.



The Department of Criminal Law and Criminal Procedure of St. Petersburg State University of Economics was formed as a result of the merger of the Department of Criminal Law of St. Petersburg State University of Economics and Finance and the Department of Criminal Law and Criminal Procedure of St. Petersburg State University of Engineering and Economics in 2012. The Department of Criminal Law and Criminal Procedure employs 11 teachers, including 3 professors and 4 associate professors. The issues of theoretical analysis and improvement of criminal and criminal procedure legislation in the field of countering criminal offenses against public safety and public order, in particular, with violations of safety rules during mining or construction work, both in the Russian Federation and the Republic of Kazakhstan, were worked out. During the meeting, criminological problems of crime prevention, safety rules for mining or construction work, as well as issues of law enforcement practice were discussed. Also, during the meeting, problems related to the administrative legislation of the Russian Federation and the Republic of Kazakhstan, which have been undergoing a deep reform process in recent years, were discussed. From the standpoint of scientific, theoretical and legal commentary on certain types of administrative

offenses, the administrative and legal aspects of the mechanism for ensuring safety and labor protection in both countries were considered. The institute of administrative responsibility in the system of administrative and legal methods of public administration in the sphere of labor and social protection was also studied. Within the framework of this meeting, problems related to the identification of promising areas of combating crime in the field of labor protection; issues of qualification of these criminal law violations; improvement of criminal legislation, investigative and judicial practice; criminological forecasting of the state, structure and dynamics of violations of labor protection rules were considered. We exchanged scientific literature and opinions on the topic of the study, in particular, on criminal liability for violations of the rules for ensuring working conditions and safety. We worked in the library, which contains scientific literature on the topic of research. Scientific papers (monographs and dissertations) devoted to the problem of qualification and prevention of violations of safety rules during mining or construction work were studied



The business trip to St. Petersburg achieved its goal. The tasks of the business trip carried out within the framework of the scientific project's calendar plan have been fully completed.
